- 5. The earnest money already deposited as security shall be refunded to the successful bidder when the lease term expired after getting necessary clearance from concerned offices, and deductions of any outstanding fees, dues if any.
- 6. The successful bidder shall execute lease agreement with the Authority. At the time of agreement execution, the successful bidder shall handover the signed checques in advance of each monthly lease money payable by the successful bidder as a guarantee to the Authority.
- 7. The Successful bidder shall be liable to collect the parking fee in accordance with the approved rates of Authority.
- 8. The Successful bidder/lease holder shall have no right to use the Parking Space for any other purpose.
- After the expiry of the lease period the lease holder shall cease to run any business or receive any fees, remove his personnel and hand over the possession of the Parking Space to the Authority.
- 10. The successful bidder/lease holder shall be responsible for timely payment of all Government duties and taxes levied from time to time.
- 11. In case the highest price bidder fails to sign the lease agreement, the Authority shall forfeit the Bid Security and may offer the next highest bidder for award of contract if the quoted price is above reserved price.
